Haskell Termite & Pest Control has been contracted to Tent Fumigate your building to eliminate an infestation of Drywood Termites. This process will require you to vacate the entire building for Two Nights with re-entry on the third day approximately 12-2pm. If you will be staying at a motel or hotel, be sure to request a flexible cancellation policy, in the event the tenting needs to be postponed or rescheduled due to inclement weather. \*

- **DAY 1:** Tent and induce fumigant into structure.
- **DAY 2:** Remove tent, gas lines, etc. and begin aeration procedures.
- **DAY 3:** Final cleanup and aeration with Inter-scans.  
*Typically return 12-2:00 pm.*

**COMMUNITY MEETINGS – JUNE 12 & JULY 1, 6 pm, CLUBHOUSE:** Please try to attend! ASK YOUR QUESTIONS AND PICK UP YOUR FUME BAGS.

**PREP INSTRUCTION FORM:** Sign, **PRINT** your name; provide bldg.. & unit, & emergency phone #. Keep a copy for yourself as reference.

**Return your signed form, and a labeled WORKING SET OF KEYS\*\* at the community meeting, or to assigned building captain (TBD) OR TO AMERITECH, no later than one week prior to YOUR tenting date.**

**DOING YOUR PREP:** You will receive special bags (Nylo-Fume Bags) to seal food items as needed at the meeting or can get from Barry. **NOTE: Food/drugs that are not sealed properly, (double bagged in the special**

**Nylo-Fume Bags provided)** may be discarded by the Fumigation crew. Follow instructions on the Prep Form, let us know if you have questions.

**DAY OF TENTING:** Please open all blinds/ curtains so service personal can access your windows for aeration purposes. No inside doors or storage units to remain locked. Please **move your cars prior to \*\*7:30 a.m.** on the day of fumigation since Haskell will have heavy equipment/trucks on the street/parking lot. **Please vacate your unit by 8:00 A.M & turn off your AC when you depart.**

**\*NOTE:** If you notice strong winds or inclement weather on the morning of your fumigation, call 813-239-1790 to confirm commencement of the fumigation.
