### **APPROVAL OF MINUTES:**

Waived reading of minutes of previous meeting BOD, minutes were approved. Motion by Michele, seconded by Jim.

#### **APPROVAL OF FINANCIALS:**

- Delinquency Update: Reviewed each delinquent account and plan of action for recovery. Agreed to letter at 60 days from Ameritech, 90 days or over, send to attorney, noted that approximately \$36K in delinquency
- **Budget Overages**: Reviewed supporting documents for budget and operating income. Discussed adding contingency account, attempt to eliminate financing of insurance premium.
- Priority of Projects and Maintenance Spending Allowance/Limitations:
  - Discussed walk of property last week, re-sodding in progress by Rene, "grinder" for sidewalks after sod complete. Lights taken care of by Duke Energy. Look at lights on front entrance, plan for electrician to review.
  - Discussed list of projects, Discussed current funds available through monthly allocations. BOD agreed upon spending allowance set at \$1000 per month to include up to 2 fences per month. Reviewed need to inspect buildings on a rotating basis for maintenance work versus only repairs.
  - o Discussed gutters, will investigate outside resource for evaluation
  - o Roof-have enough in reserve for next roof for repair, 1833-1839.
- Motion to approve financials by Tony, seconded by Kiva.

#### **NEW BUSINESS:**

• **Paving Needs:** Discussed reserve available to work on paving/sealing needs of the community. Awaiting the remaining two bids. Have \$51K in reserves. Will await bids from Stephanie and then make a decision.

- Communication with Owners: Discussed email list of owners: Stephanie has 21. Sign out front for meeting notice noted with positive response from BOD and homeowners. - Fire Extinguishers: Completed 1-24-18.
- Recycling bin (2018 budget approved): grassy patch near 1834. 4 receptacles and supposed to pick up on Wednesdays, Stephanie in contact with WastePro; consider other contractors if not kept up.
- **Ditches:** City of Clearwater and Mosquito Control has been contacted, on the list for ditch trenching and clean out, property has been treated for mosquitos.
- Updated House Rules: Reviewed and revisions made during meeting, will have next version available for BOD to approve. Discussed need for "Fining Committee"
